AM19 Para 13.12 & AM23 Para 13.50	David Cooper/Stop 350	Climate Change. No mention of the consequences of Sea level rise for Mersea Island has been added as we requested to the Inspector. We believe this is so critical not only to Mersea Island but also all the low lying areas normally protected by the Colne Barrier and sea walls now at risk. With sea level rise certain to increase by more than the predicted 1 metre, due to an expected greater increase of the temperature of more than 1½ degrees, by end of this century. (now expected to be 2.7 degrees) The inspector did considered, in the case of Mersea Island, the lack of road access was too detailed a matter to be considered in the Local Plan! Councilors will be well aware of the flooding at the Hythe which causes chaos every time a small high tide occurs and the Barrier is closed! Big tides can cause up to 3 hours of traffic chaos for the access to Mersea Island. There being some 13,033 vehicles on average which use this Strood crossing on the B1025 every day. Whilst paragraph 13.12 considers the "environment" a new paragraph 13.11 replacing the removed one should also consider development effected by sea level rise. Replacement para. 13.11 with	Paragraph 13.11 was related to green infrastructure, not sea level rise. Impact of sea level rise is considered in Policies CC1 and DM23. The Council do not consider this proposed wording is required.
