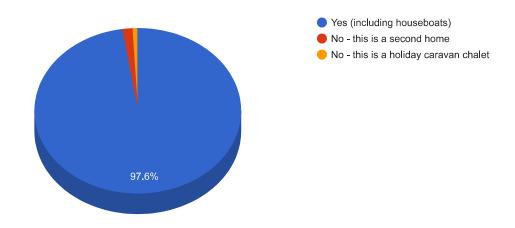


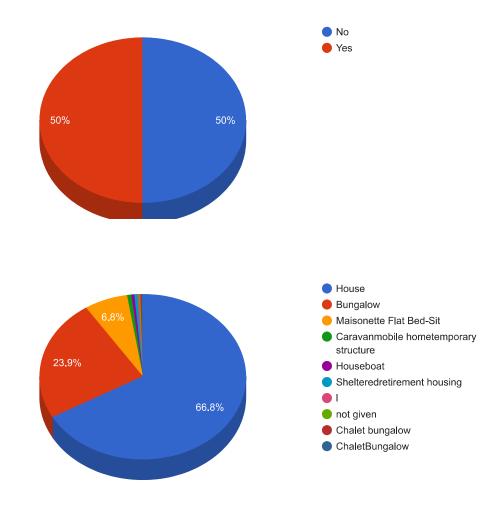

2: Is this your main home where you live?

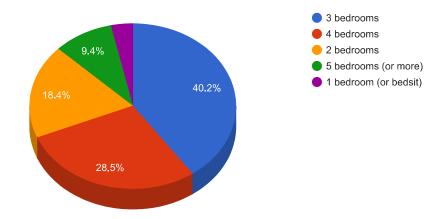

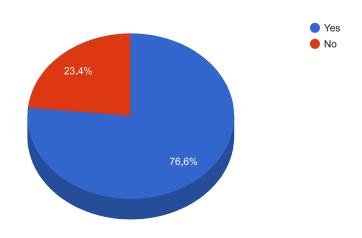

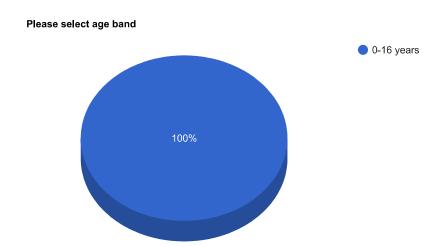

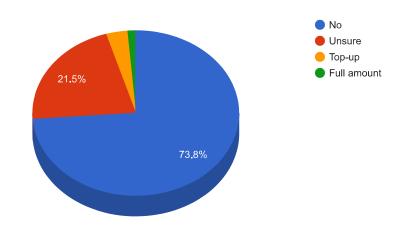
