If after the formal democratic process currently ongoing at Basildon Council, the response is dramatically changed, then Basildon will write to withdraw officer comments. I hope this is acceptable.

Colchester Borough Council and Basildon Borough Council should seek to work together moving forward as required by Duty-to-Cooperate. Colchester Borough Council should also note the upto-date examination of Gyspy, Traveller and Travelling Showpeople Local Needs Accommodation Assessment which has been carried out for the Basildon Borough; the raw data for which has also been used to inform the wider Essex Gyspy, Traveller and Travelling Showpeople Local Needs Accommodation Assessment currently underway. Each Local Planning Authority should be mindful that the findings of, and updates to, this strategic evidence base, are within the remit of the Duty-to-Cooperate insofar as the additional provision of Gypsy, Traveller and Travelling Showpeople accommodation is a strategic matter, the solution for which could include provision outside the area where the need is forecast to be generated. This may result in a need to inform the area's emerging Local Plan documents, or could prompt, a more comprehensive Local Plan document review, where adopted policies cannot otherwise manage the changing needs identified by evidence.
