Name of policy to be assessed:

Colchester Northern Gateway Sports Hub

  - To approve the funding package and financial details for the development of the sports and leisure hub north of the A12 at the Northern Gateway to include the relocation of the rugby club and playing pitches, creation of new cycling facilities and sports hall in a parkland setting
  - To note that following further work on the proposed procurement route will brought back to members for approval and that the scheme requires planning consent
  - To note that it has been agreed at a previous cabinet meeting that the partial development of the Mill Road rugby club site for a mix of residential uses can provide enabling funding subject to a suitable housing delivery model, financial implications and risk management and that a previous business plan was approved in November 2016.

  - Creation of new public sports and leisure facilities including a sports hall, rugby pavilion and outdoor sports and recreation for use by clubs and the local community and including future potential work with health providers

  - No changes to existing policy but the project addresses many of the needs identified in the borough Playing Pitch and Leisure Facilities Strategy 2015

  - A new leisure destination that is viable and is environmentally sustainable and will enhance the opportunities for recreation for all members of the community
