Allocation of council owned properties 1-6 St John's Place

1. What is the main purpose of the policy, service or strategy?

Reclassification of properties 1-6 St John's Place to general needs
Council owned properties in St John's Place, currently allocated to tenants with an assessed need for sheltered housing will no longer be allocated to tenants who need sheltered housing.

Colchester Borough Council has developed a 'Colchester Standard' for sheltered housing which sets out the facilities which should be included in all sheltered housing. The reclassification of St John's Place is intended to phase out sheltered housing which does not have the design features expected in housing for use by older people and cannot offer the services and facilities identified in the Colchester Standard. In order to achieve CBC's aspiration for its sheltered housing in the future the properties at the St John's Place will no longer be specifically allocated to tenants who need sheltered housing
2. What main areas or activities does it cover?

- Allocation of council owned properties in St John's Place currently designated as sheltered accommodation will be allocated as general needs when vacancies arise.

3. Who are the main audience, users or customers who will be affected?

- Current tenants of sheltered housing in St John's Place
- Colchester residents interested in living in general needs or sheltered accommodation
- Colchester residents with low level support needs

- To make sure that current tenants of sheltered accommodation in St John's Place are able to live in and receive the same housing related support service in their homes for as long as they wish or until the property no longer meets their housing support or care needs.
- To increase choice for tenants who require general needs accommodation
- To provide specialist accommodation for tenants with low level support needs

- Older people will still be eligible for these properties even when their use is changed to general needs.

- The improvement of Sheltered Housing accommodation to the 'Colchester Standard' across the Borough will provide an overall benefit to this group.

Current tenants in flats designated as sheltered housing in St John's Place will continue to be able to enjoy the provision of the sheltered service for the duration of their tenancy or until the property no longer meets their housing, support or care needs.

General needs flats in the area will be let under a local lettings policy to ensure that a suitable allocation is made. This will take into account the needs of both current and prospective tenants.
