1. Introduction

Colchester City Council has commenced work on reviewing the Local Plan. The Local Plan Review will need to allocate land for the provision of homes and other uses to meet the City's future and existing needs.

In 2023, the Council drafted and consulted on Strategic Land Availability Assessment (SLAA) Methodology. The comments received were presented to Local Plan Committee on 11 December 2023. The adopted SLAA Methodology can be viewed on the Council's website as part of the Local Plan Review Evidence Base and Supporting Documents: https://www.colchester.gov.uk/local-plan/evidence-base-supporting-documents/

As part of the SLAA process, the Council launched a Call for Sites in Autumn 2023. The Call for Sites is an opportunity for groups to suggest sites that they would like to be considered to inform the preparation of the Local Plan. Further information on the sites submitted through the Call for Sites can be found in the Strategic Land Availability Assessment (SLAA): Call for Sites Report.

In addition to the sites received through the Call for Sites process, the Council, as set out in the SLAA Methodology, have proactively looked to identify any additional potential sites and locations for growth or green uses to be assessed through the SLAA process, to ensure its approach to new land allocation is comprehensive. This part of the SLAA process is called the 'Desktop Review' and further detail is provided in the SLAA Methodology and Strategic Land Availability Assessment (SLAA): Desktop Review Report.

This report provides a comprehensive overview of all the sites (those generated from the Call for Sites and Desktop Review) which have been assessed in accordance with the SLAA Methodology and sets out the outcomes of the SLAA Site Assessments Stage 1.

2. Submissions

Table 1 below sets out the total number of submissions to the Call for Sites and Desktop Review process. The Call for Sites submissions can be seen in the <u>Call for Sites Report</u> and the Desktop Review submissions can be seen in the <u>Strategic Land Availability Assessment (SLAA): Desktop Review Report.</u> The total number of submissions is different to the number of sites, as varying data sources have been used through the Desktop Review and a site could have been submitted by more than one individual to the Call for Sites.

A total of 289 submissions have been made for consideration through the SLAA.

3. Duplication of Sites

Residential

Duplication of sites can occur through either the same site being submitted by more than one person to the Call for Sites, where multiple data sources have been used within the Desktop Review or where a site has been identified through the Desktop Review and also submitted to the Call for Sites.

The Desktop Review Report sets out where more than one data source identified the same site. Therefore, duplication of sites within the Desktop Review has already been considered.

Where a site has been identified through the Desktop Review and Call for Sites, the boundary from the Call for Sites has been used as this is the most up to date information available.

Where a site has been submitted by more than one person to the Call for Sites, the information from each submission will be considered through the SLAA, however the site will only be assessed once.

The table below sets out which submissions have been excluded from further assessment as they are considered a duplicate and to avoid the same site being assessed twice.

4. Sites with Overlapping Boundaries

Residential

Sites with overlapping boundaries can occur when a site has been submitted for different scales of development or where additional uses are proposed within one submission.

Where site boundaries have overlapped, the largest site has been assessed, however the assessment has had regard to the smaller scale of development proposed.

The following submissions have been excluded from further assessment to avoid the site being assessed twice.

Commercial and Infrastructure

There have been no overlapping boundaries of sites identified for commercial, and infrastructure uses.

Green Infrastructure

There have been multiple instances of overlapping boundaries from the submissions of Middlewick Ranges, which has included areas known as Birch Brook Wood and Weir Lane Grasslands. As a result, a composite assessment will be undertaken for Middlewick Ranges, Birch Brook Wood and Weir Lane Grasslands.

5. Total Number of Sites

Taking into account duplication of sites and sites with overlapping boundaries, there are a total of 250 sites identified for assessment through the SLAA.

Table 5 below provides a breakdown of the number of sites for each proposed use. A total of 231 sites have been submitted for residential uses.

6. Stage 1: Initial Survey


Stage 1 of the site assessment process determines whether a site is suitable or not for future development taking into account national policy and designations, and whether a site should progress to the next stage of the SLAA.

For clarity and transparency, some additional points of how the criteria has been applied consistently across the assessments are set out below:

- "Does the site have extant planning permission? Has development commenced?" – planning permission for the proposed use of the site has been considered only
- "Is the site physically isolated in the open countryside?" Where a neighbouring site has also been promoted, and development of the two sites together would prevent the site being physically isolated this has been considered suitable
- "Can the site be access by vehicle from the public highway?" the assessment refers to proximity to a classified road which is different to the public highway which is referenced in the question. For consistency access by vehicle has been assessed in relation to proximity and access to the public highway. Where a neighbouring site has also been promoted that could provide vehicle access if developed together, this has been considered suitable.

A total of 242 sites have been considered through Stage 1 of the assessment for residential and commercial uses.

68 sites (28.1%) have been considered unsuitable and are therefore omitted from further assessment. A total of 174 sites (71.9%) have been considered suitable. See graph below.



A full list of the omitted sites and the reasoning for their omission is stated in Appendix 2.

As set out in the SLAA methodology, any sites identified for infrastructure and green infrastructure have proceeded straight to stage 2 of the assessment.

Therefore 174 sites have progressed to Stage 2.

7. Next Steps

A further report will be produced to set out the findings of the Stage 2 Site Assessments. This will include details regarding the sites assessed for Residential, Commercial, Infrastructure and Green Uses.
