## Colchester Levelling Up Fund (LUF) Bid

I am writing to express Essex County Council's strong support for Colchester's Levelling Up Fund bid. The projects included in the bid will transform eastern areas of the city centre and improve the life chances and opportunities for the residents of Colchester.

Reference: Levelling Up Fund Round 2 Bid

I am delighted to be able to offer my support for this funding application to the Levelling Up Fund on behalf of the Safer Colchester Partnership. The Partnership consists of several statutory agencies and voluntary organisations, colleagues in the NHS, Essex Police, Essex Fire and Rescue Service, Colchester Community Voluntary Service, Colchester Borough Homes, Colchester Garrison, Essex Probation and Essex County Council, who work together to reduce crime and disorder in Colchester.

Following an assessment of crime and disorder, the Partnership identified three specific priorities for 2022/2023 and it is evident that within this bid, the specific interventions meet those key priorities. The key objectives are:

- 1. Tackling organized crime, gangs & county lines with an emphasis on Drug Trafficking
- 2. Driving down Anti-Social Behaviour and Violent Crime in public, focusing on Hate Crime and possession of weapons
- 3. Identifying & supporting the victims of Domestic Abuse and Sexual Offences, focusing on reducing Violence Against Women and Girls (VAWG)

Historically there has been and continues to be an elevated level of ASB (Anti-Social Behaviour) within the St Botolph's and Priory area of Castle Ward, with much of this attributing to fear of crime particularly in the urban design of the underpass routes. In a consumer survey conducted by Colchester Business Improvement District, visitors to the Town Centre highlighted that these areas were often frequented by large numbers of individuals behaving in a manner that causes distress and a feeling of insecurity. The proposed development within the bid will provide the opportunity to design out crime, bring reassurance to residents regarding their personal safety, assist in reducing crime rates and improve the quality of life for the wider community.

Layout of communal spaces, use of lighting, perimeter security and landscape planting, highlight the design decisions that could increase the risk of crime and ASB, therefore the regeneration and development of this section of the Town will reduce these risks significantly. Alongside this, the new route proposed from Colchester Town Station through public spaces enables consideration to be given to the risk of Terrorism and implementation measures can be incorporated. This is particularly vital as Colchester is a Garrison Town.

Therefore, on behalf of the Safer Colchester Partnership, I fully endorse this Bid as I believe the measures within it will have a significant impact on public confidence in relation to crime and will reduce the opportunity for Crime and disorder in the parts of the Town Centre being addressed.

I am writing on behalf of the University of Essex in support of Colchester Borough Council's application for funding from the Levelling Up Fund Round 2.

The University of Essex particularly welcomes the focus of the Council's proposal on regeneration of the south-eastern quarter – the area of the city closest to our campus. The receipt of these funds would contribute to regenerating our city, making it both more vibrant and safer, attracting investors and addressing access and other long-standing needs and deficits. The improvements would improve safety and would be expected to reduce crime and antisocial behaviour. We would also be extremely supportive of the improvements in accessibility that these funds would provide in addressing the currently limited access to this part of the city for cyclists and pedestrians, many of whom are our students and staff. The area in question is of historical importance to the city that was Roman Britain's first capital; through these funds, these assets would be made more visible than currently, showcasing and protecting them, and also impacting positively on the lives of all those who live, work and study around them, and increasing civic pride.

For a number of years, we have also been working with business to further the economic growth and development of the region. The University's Knowledge Gateway research and technology park in Colchester continues to grow and is becoming the location of choice in the east for knowledge-based science, technology and digital creative companies. Organisations are being attracted to the park by the link to the University but also in large part by the rapid growth in population and scale of Colchester, in recent years backed by major regeneration efforts by Colchester Borough Council. Currently, however, there is a disconnect in the presentation and sense of place in the areas of the city located between the Knowledge Gateway and the St Botolphs and Priory area. Creating a more attractive channel into the eastern part of the city, linking the Knowledge Gateway with the centre, would be expected to augment the investment possibilities in the area.

All aspects of the proposal will help to make Colchester an even more attractive place to live, work and study and will therefore support the continued growth of the University of Essex at the Colchester Campus and the positive contribution this makes to the social and economic life of the city.

I have no reservation whatsoever in expressing the University's support for Colchester Borough Council's bid in relation to the Government's Levelling Up Fund, Round 2, and look forward to working with the Council as these projects develop.
