(i) Venue

Noting that the new venue is confirmed as acceptable by the Council and Appellants for the same dates (13-16 Dec), I leave it to the Council to ensure that the usual facilities will be available:

(ii) Landscape Evidence

Further to the Case Management Conference, I consider that the submitted Landscape evidence lends itself to cross-examination (XX).

(iii) Wivenhoe PC and other third party evidence

For efficiency and fairness, and still subject to discussion and confirmation in opening, I anticipate that Wivenhoe PC will make a brief opening statement indicating its main areas of concern.

Then, under the Landscape topic, WPC may, before re-examination, ask any relevant questions of the TWL landscape witness that have not been raised by CBC and may also make any further points of their own on the landscape topic.

The same will apply with respect to the Planning topic where WPC will have the opportunity to ask relevant questions of the TWL witness (and CBC but strictly where there is a clearly opposing view) and make relevant comments not so far covered. These might include the extent and size of the appeal site compared with the WNP allocation and the proposed housing density.

I have included a round table session (RTS) on Other Matters which may include other WPC points on such as: footpaths; ecology; flood alleviation measures; and access to open space.

Finally, having agreed at the CMC to hear an opening statement by WPC, I will also hear a closing statement by WPC, if it wishes to make one, before those of the main parties, albeit that is optional because all the evidence will be taken into account in any event. Closing submissions must not involve repetition nor introduce new points. If that option is taken up, a transcript will be required.

Any other third parties will be included as appropriate.

- (iv) Rebuttals I have received by the due date rebuttals from the Appellants (planning and landscape), the Council (planning) and WPC.
- (v) Site Area I note that the site area is clarified by the Appellants as 15.02ha and this will be confirmed in opening.
