How we collect and use information

The information collected by Colchester City Council on this form and from supporting evidence will be used to process your application. The information may be passed to the Department of Social Security, Employment Service and Inland Revenue as permitted by law.

We may check information provided by you, or information about you provided by a third party, with other information held by us. We may also get information from certain third parties or give information to them to check the accuracy of information, to prevent or detect crime, or to protect public funds in other ways, as permitted by law. These third parties include Police Authorities, Government Departments, and local authorities.

Town Police Clauses Act 1847 Section 40

In every case in which the proprietor of any such hackney carriage permits or employs any licensed person to act as the driver thereon such proprietor shall cause to be delivered to him, and shall retain in his possession, the licence of such driver, while such driver remains in his employ; and in all cases of complaint, where the proprietor of a hackney carriage is summoned to attend before a justice, or to produce the driver, the proprietor so summoned shall also produce the licence of such driver, if he be then in his employ; and if any driver complained of be adjudged guilty of the offence alleged against him, such justice shall make an endorsement upon the licence of such driver, stating the nature of the offence and the amount of the penalty inflicted; and if any such proprietor neglect to have delivered to him and to retain in his possession the licence of any driver while such driver remains in his employ, or if he refuse or neglect to produce such licence as aforesaid, such proprietor shall for every such offence be liable to a penalty not exceeding [level 1 on the standard scale].

Local Government (Miscellaneous Provisions) Act 1976 Section 48 (3)

In every vehicle licence granted under this section there shall be specified –

- (a) the name and address of -
 - (i) the applicant: and
- (ii) every other person who is a proprietor of the private hire vehicle in respect of which the licence is granted, or who is concerned, either solely or in partnership with any other person, in the keeping, employing, or letting on hire of the private vehicle.
