

Myland and Braiswick Neighbourhood Development Plan 2016-2032 (Reviewed 2022-2023)

Sustainability Statement

This Statement is required by Regulation 16(4) of The Environmental Assessment of Plans and Programmes Regulations 2004.

Background

Colchester City Council decided by resolution at Full Council on 18th October 2023 to make the Myland and Braiswick Neighbourhood Development Plan (Reviewed 2022-2023) under Section 38A of the Planning and Compulsory Purchase Act 2004 (as amended). The Myland and Braiswick Neighbourhood Development Plan forms part of the Development Plan for Colchester.

The Myland and Braiswick Neighbourhood Development Plan covers the area designated by Colchester Borough Council ¹ as the Neighbourhood Plan Area in 2013.

How environmental considerations have been integrated into the plan or programme.

Environmental considerations have been integrated into the neighbourhood plan. The Neighbourhood Plan contains an objective to ensure that sensitive development design will help meet the challenge of climate change and protect and enhance the natural and historic environment. This is reflected in policies that aim to maximise opportunities for the creation, restoration, enhancement, expansion and connectivity of green infrastructure within and between development sites; and to ensure that development proposals make a positive contribution towards protecting and improving the local environment and biodiversity within the Plan area. Policies also aim to protect and enhance Highwoods Country Park's diverse biodiversity habitat. The Myland and Braiswick Green Network was adopted by the Community Council in 2021 and the Neighbourhood Plan includes a policy to protect this green network to avoid unjustified loss of the identified green spaces and maintain connectivity between those green spaces.

How the environmental report has been taken into account.

The environmental report was prepared alongside plan preparation. As the Plan does not make allocations for housing sites, the comments on the Environmental Report were limited. No amendments or requirements for mitigation were recommended as the Policies adequately cover the relevant issues.

How opinions expressed in relation to the environmental report have been taken into account

As the Plan does not make allocations for housing sites, the comments on the Environmental Report were limited. Two representations were received in relation to the environment report. These were from Natural England and Historic England, both of whom have limited comments as the Plan does not allocate land for housing. Natural England responded and confirmed that, based on the information provided, in their view the proposals contained within the plan will not have significant effects on sensitive sites that Natural England has a statutory duty to protect. Historic England responded and confirmed that, on the basis of the information supplied, Historic England concurs with the Council that the preparation of a Strategic Environmental Assessment is not required. No amendments or requirements for mitigation were recommended.

No amendments to the Neighbourhood Plan were necessary as a result of responses to the Environmental Report.

How the results of any consultations entered into under regulation 14(4) have been taken into account

No consultations under regulation 14(4) were entered into.

The reasons for choosing the plan or programme as adopted, in the light of the other reasonable alternatives dealt with

The Plan does not allocate sites for housing so there were a limited number of alternatives as the majority of policies look at the principles of promoting sustainable development and meeting the needs of the parish within the plan period, adding to the principles established in the Colchester Local Plan which provides the Strategic Planning Framework.

The measures that are to be taken to monitor the significant environmental effects of the implementation of the plan or programme

Colchester City Council produces an Annual Monitoring Report, which monitors the implementation of planning policies. It includes a range of environmental indicators, which will be used to monitor the significant environmental effects of the implementation of the plan.
