NOTES

This must be sent to the Licensing Team at Colchester City Council by email or via post at Rowan House, 33 Sheepen Road, Colchester, CO3 3WG no later than the end of the third month after the date of the lottery.

The document(s) making this authorisation and the appointments for promoter (or a certified copies thereof) must be lodged with the Council.

Paragraph 39 of the Gambling Act 2005

Any person who fails to complete and send a return in accordance with the provisions of this part of this schedule, or who knowingly gives within any such return any information which is false in a material particular, or who certifies any such return knowing it to contain such information, shall be guilty of an offence.

A non-commercial society lottery commits an offence if –

- a lottery, purporting to be an exempt lottery under Part 4 of Schedule 11, is promoted on the society's behalf wholly or partly at a time when the society is not registered with a local authority in accordance with Part 5 of that Schedule,
- the society fails to comply with the requirements of paragraph 39 of that Schedule, or
- the society provides false or misleading information for the purposes of Paragraph 39 of that Schedule.

Any person found guilty of an offence under this Part shall be liable on summary conviction to-

- imprisonment for a term not exceeding 51 weeks,
- a fine not exceeding level 5 on the standard scale, or
- both
