

Colchester Focused Local Plan Review Modifications Consultation



In the context of this Focused Review we have significant concerns about the application of this wording to policies in a Development Plan Document. Those concerns are set out in our Statement on the Scope of the Focused Review at paragraphs 3 to 8. We are not satisfied that there has been adequate rigour applied to many of the policies that are subject to this review with the effect that whilst parts of policies may become NPPF compliant, other parts of often very lengthy policy text may remain, to varying extents, non-compliant. As paragraph 154 of the Framework explains, Plans need to "provide clear indications of how a decision maker should react to a development proposal".
Whilst our Statement on the Scope of the Focused Review (at paragraph 8) puts forward a possible compromise, this would only serve to demonstrate that the whole of relevant policies are either not sound or are at risk of being non-compliant with the NPPF.
The alternative is not to review policies where there is any unresolved uncertainty as to whether the Review has properly been able to address the whole of the policy, whether for reasons of omission or otherwise.
Thus, considerable caution needs to be applied before using this "health warning" to provide confirmation about the status of relevant policies.
Thus, the text used must not be seen as a "starting point" but an important conclusion to the process and may need to be tailored to individual policies.
It cannot serve to make anything sound that is not.
Our concerns are played out in the context of the limited change proposed to Policy DP7 (subject to MAJ3).
