We object to these changes and provide relevant justification in our Statement on Retail Policies to the Examination within paragraphs 1 to 19. Paragraphs 17, 18 and 19 specifically relate to this matter. Since the sequential approach is a series of preferences (paragraph 24 of the NPPF), the proposed phrase "should be located" is out of place.

We do not accept that proposed changes in the Focused Review to this matter stray into matters of spatial strategy. What the conditional modification (MAJ14) would achieve is the application of a fundamental plank of Government policy to the Development Plan here and where the up to date evidence base confirms that the sequential approach should apply consistent with Government policy.
