##### Modification Ref – MAJ16 (Policy CE2b)

4. Do you have any comments on the proposed modifications, taking into consideration paragraph 182 of the National Planning Policy Framework which sets out the tests of 'soundness':

Schroeder UK Property Fund considers that the deletion of the second sentence of the second paragraph of the Policy would make the revised wording of Policy CE2b **sound**. It is considered that the proposed modification would make the Policy **consistent with National Policy** in relation to town centres within paragraphs 23-27 of the National Planning Policy Framework (NPPF). As such the proposed Major Modification 16 is supported.
